CSPRRC (from the National Newsletter)  
 The RCD discusses the travel fund for the CSPRRC and put forth two proposals. The RCD desires member input as to the desirability of these two proposals:  
 1) The effective 1/1/83 raise the tow fund contribution from National races from \$5.00 to \$10.00.  
 2) Have a non-refundable \$100.00 entry fee for CSPRRC that would be placed in the travel fund.

SOLO EVENTS BOARD MEETING  
 Effective immediately, the first portion of section 10.2.A.2.a be changed to read as follows:  
 \*a. Any make and size tire may be used provided:  
 1.) The model of tire is listed in a 1981 or later edition of the Tire Guide (or has otherwise been approved by the Solo Events Board) and has Department of Transportation (D.O.T.) approval. No racing tire or recap (on any casing) may be used.\*
